## Could tribe open casino here?

A Lake George businessman suggested to *The Chronicle* that maybe Warren County isn't out of the running for a gambling casino after all.

In New York's push for a constitutional amendment authorizing some non-Indian gambling casinos, the state excluded Warren, Clinton, Essex, Franklin, Hamilton, Jefferson, Lewis and St. Lawrence counties as possible casino sites, in exchange for the St. Regis Mohawk Tribe agreeing to an immediate \$30-million payment from the Akwesasne Mohawk Casino to resolve past revenue-sharing payments.

State Senator Betty Little said at the time that the Saint Regis Mohawk Tribe "was really concerned about losing the exclusivity...Warren County is kind of far from Saint Regis, but they believe people in the Adirondacks would go to a casino in Lake George and not north. That was a real problem for them."

Now the Lake George business owner posits that the pact allows the Mohawks themselves to open
