Snowy owl at FE grasslands

A male snowy owl — seen in this photo by Dr. Gordon Ellmers of Fort Edward — has made its way to the farm fields of Kingsbury and Fort Edward.

It's the first sighting of a snowy owl in the Fort Edward grasslands this winter. There were no sightings last winter. Snowy owls come from the Canadian Arctic but are an increasing presence in the northeast U.S.

Ornithologists believe it's because of a population explosion back home.

The thinking is this: Snowy owls feed on lemmings, a rodent that lives in colder climates. When there are lots of lemmings, the owls reproduce in large numbers, laying more eggs than normal.

When the younger birds are ready to establish their own hunting and breeding territory, they are driven farther south by the adults. They've shown up here, in southern New Hampshire, Rhode Island, Cape Cod
