Says Uber drivers are like slaves...

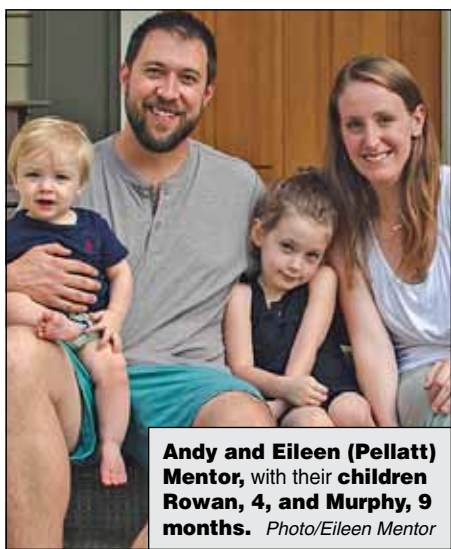
To the Editor:

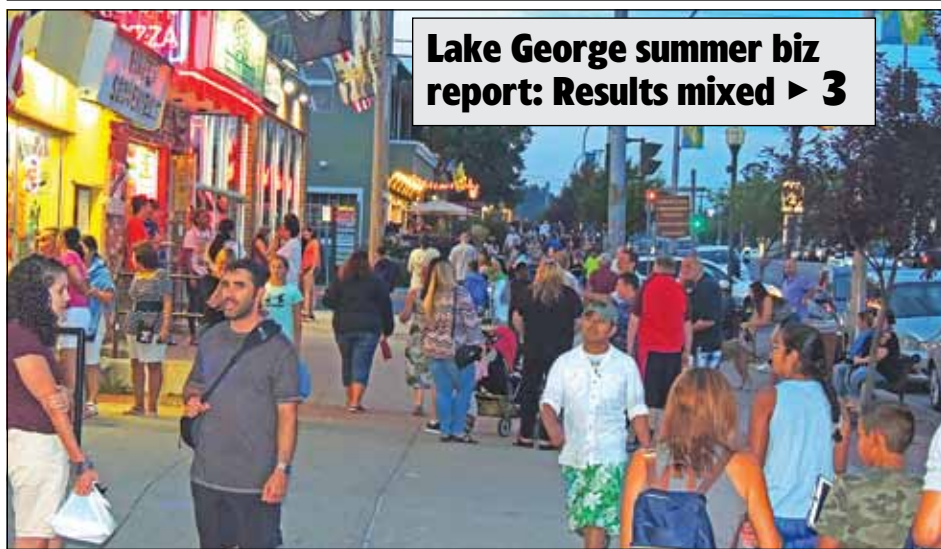
No one should question the greatness of America's ideals.
