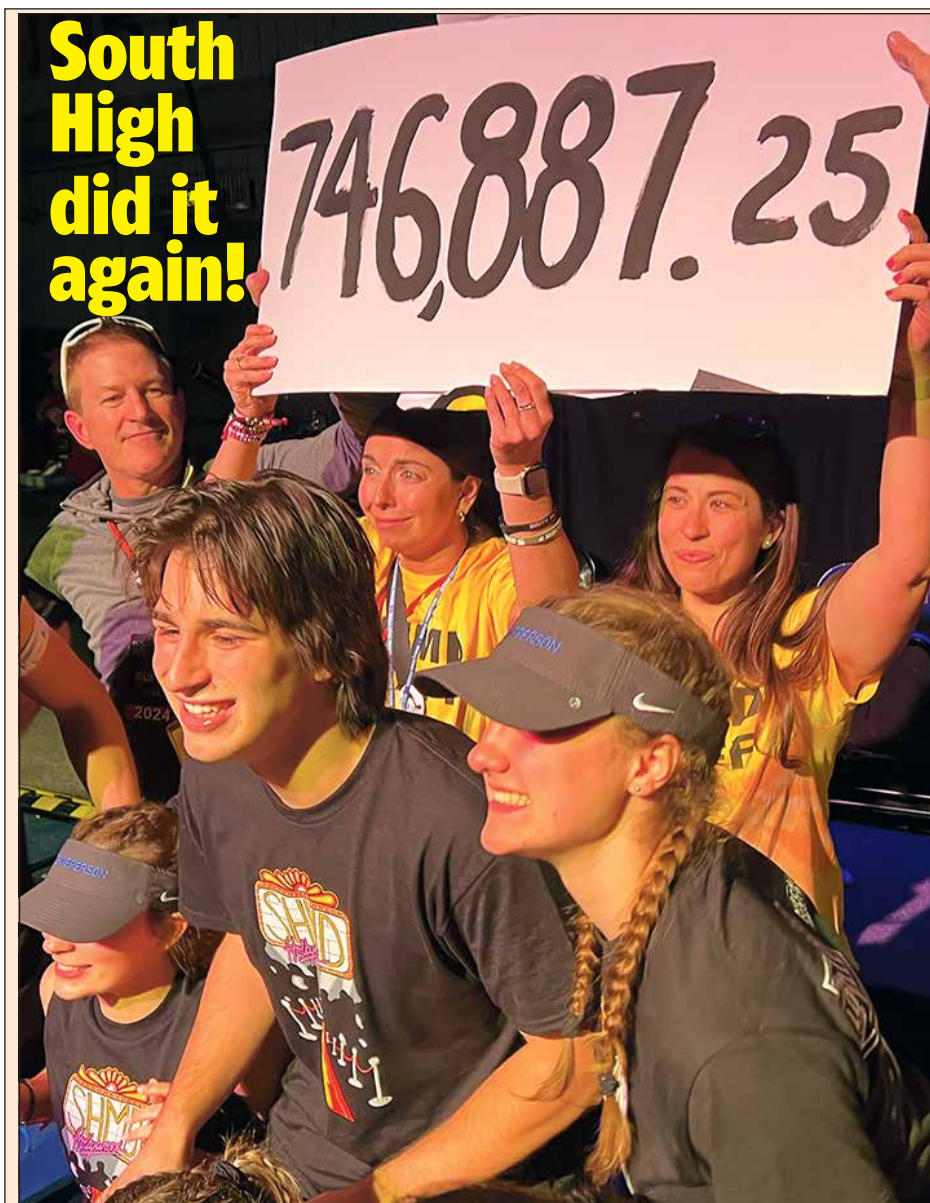

The Glens Falls Planning Board recommended OKs for two separate cannabis dispensaries, the city's first, March 5.

Legacy Dispensary is planned at 12 Hudson Avenue in the building that right now is a Pizza Hut. The newly named **GF Cannabis Co. is planned at 72 South Street** at the former Dizzy Chicken first came before the Planning Board as Saratoga Cannabis Co. The stores still need New York State approval.
